The English Syllabus of Surnandan Bharati was published on 19th November 1997.

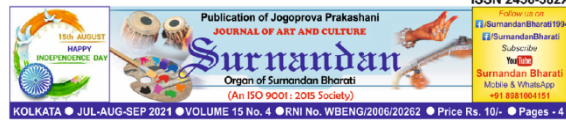

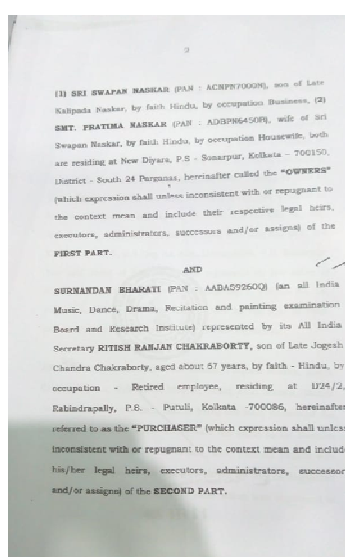
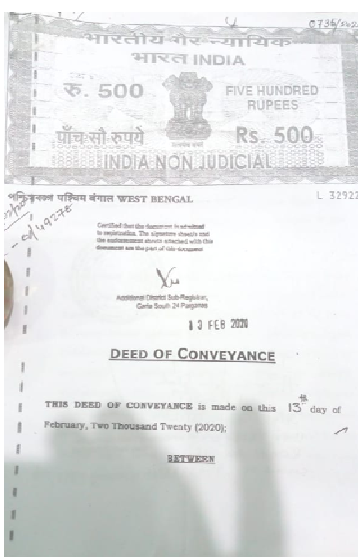
